To the Brethren of the Most Worshipful Grand Lodge of Ancient Free and Accepted Masons of New Mexico,

The following is just a part of the Grand Masters Address that will be given at the 2024 Annual Communication March 14th – 16th, 2024. I wanted to share it with those who will not be able to make the journey.

Good morning,

I want to welcome you to the 147th Annual Communication of the Most Worshipful Grand Lodge of New Mexico, here in the beautiful village of Ruidoso, New Mexico. I hope that each of you and your families are having a great and memorable time. Our host, The Inn of the Mountain Gods wish the same. Thank you for making the trip

and taking part in our annual celebration and supporting our Fraternity.

I would especially like to thank our visiting Brethren from other Jurisdictions for being here, you are truly Travelers of the Craft. Finally, let us offer a special thanks to all our spouses, families and friends who stand by us and support all that we do. If not for them, it would not be possible.

So please sit back, relax and enjoy what Ruidoso, The Inn of the Mountain Gods and the Sacramento Mountains of Lincoln County New Mexico have to offer. Rekindle old friendships and feel the warmth of new ones... most of all, rest and relax.

On April 14th, 2000, I knocked, and the door of Freemasonry was opened unto me. During the eventful ceremony of initiation, I was told that one day "even the purple of our Fraternity may rest upon your honored shoulders". I can honestly say that thought has always been the furthest thing from my mind. I just wanted to get through that evening, gather my belongings, and go home. Throughout the next day, all I could think of is "what have I got myself into?"

As time went on, I found myself being drawn to my Lodge, and wanting to be around those in attendance. The Masons who took me in seemed so knowledgeable and were always as ready to give as much as I was willing to receive. One man stood out, and not only did he become my idol if but he also became my mentor, my masonic idol, if you will. I would be remised if I did not mention him in this, my Grand Masters Address. WB Warren Wheeler of Bandera Lodge No. 1123 in Bandera, Texas, not only taught me the ritual, but he also taught me all the how's and why's of Freemasonry.

Brother Warren and his wife Doreen were ranchers, and between their two families they had thousands of Texas hill country acres. The two of us would climb into his pickup every other afternoon and drive the various pastures and I would learn the ritual. Most Saturdays Doreen

would pack us lunch and we would head out early, at times it would take hours to cross that ranch, idling along in that old green Ford, going over our masonic work. On occasion another brother would ride with us, and we would take turns practicing. He would learn a part in a degree, or go over a conferral, then I would recite my proficiencies. This practice would go on for months, one Degree at a time. Every trip we would return to the house and Doreen would ask, "how did it go?", and Warren would say "good, but he is not quite there yet, needs a little more practice".

One Sunday after driving the ranch, we returned to the Wheeler house, dinner was ready, and Doreen invited me to stay just as she had always done before. Warren went to wash up, then step outside to have a quick smoke. It was then that Doreen let me in on a hidden secret. She told me that she heard that I was ready to turn in my Master Mason proficiency months ago, and that the only reason Warren was taking his time was because he wanted somebody else to have to open all those gates at the ranch, instead of him, and that it didn't look like he was going to have another candidate for quite a while! Regardless of what she said, I never told him, I just enjoyed our rides.

Warren is long gone, and so are all those other brothers who rode with us, but their memory, and the times we had live on in my thoughts. It is through those kinds of close fraternal relationships we build the ties that last a lifetime.

Since moving to New Mexico, I have been able to build those very same relationships. Freemasonry is a universal language and a way of life. Over the past twenty years the Masons of New Mexico have given me the same knowledge and opportunities that I received in the front seat of that old pickup. In fact, more. In Texas, with a membership so large, I felt like a number. In New Mexico, here, we all have a name. Since the first time I walked through the door of Ruidoso No. 73, the first time I attended a New Mexico Annual Communication, and to this very date, it has felt like home, and I am forever grateful.



I stand here before you as Grand Master, not because of my accomplishments, but because of yours. Each one of you has taken the time to shed light to a brother who was simply seeking it. You have taught me what it is to be a Freemason and I hope I have lived up to your expectations. This past year, and the years before having been the most rewarding challenge I have ever faced. I will always carry those rewards with me, even if I am called to that Spiritual Building above.

Thank you all for giving me that opportunity.

This entire Annual Communication will be held here, at the Inn of the Mountain Gods. A Grand Masters Reception will be on Thursday night, a Public Opening Ceremony with introductions Friday morning, lunches Friday afternoon for both the men and our ladies, followed by a banquet with an awards ceremony that evening. And don't forget the Hospitality Room in the Cochise Presidential Suite on the sixth floor, just another way to enjoy each other's fellowship and say thank you too all.

The Ladies luncheon scheduled for Friday is sure to be a great time. My wife Shirley has food, fun and refreshments planned for all the attendees. The ladies have been told to bring a favorite photo or screenshot of their favorite Mason. A contest will be had with prizes awarded and sure to draw a lot of attention!

There will be a Silent Auction at the Banquet Friday night featuring wonderful items donated by Brethren and businesses of the community to help benefit our Annual Communication Fund.

The past six years have been incredible, words alone can't even begin to explain the journey you have allowed me to take as an officer, and most recently Grand Master. There is an opportunity out there for all of us to succeed and lead, all that is required is to stand up and take charge. 

This is my last contribution to The New Mexico Freemason as your Senior Grand Warden. It stirs thoughts of the year past, and hopes for the coming year.



The document has been added as an addendum to this edition of the NM Freemason, but is also available separately by clicking on the picture below.



#### **Music for Your Lodge**

Sing and Play to Provide a More Complete Experience.

I recently participated in a Master Mason degree in a really good lodge. The degree was going very well until we reached the Dirge in the second section. In this lodge, the brethren marched around silently while the secretary read the words of the song aloud. Since I was there, I played it on the piano as he read, but sometimes there is no music at all. This might be the practice in other lodges as well.

Admittedly, few lodges have a pianist or organist who can accompany the hymn. But there is nothing wrong with the brethren singing it in unison, with or without accompaniment, and even if it's a little out of tune and not perfect. There is something about the sound of voices singing together that touches us, and especially the candidate. It's the humanity of it that gives expression to our connection as brothers. I have yet to hear a great live vocal performance of Pleyel's Hymn in any lodge. Think of a church

congregation singing hymns of praise together. Not everyone is a great singer – it's the message and the feeling, not the musical perfection. I strongly doubt the guys who built King Soloman's Temple were great singers.

In my previous position of Music Director of a state-wide children's dance program, we always included a cast song for all the children to sing together. The majority of the voices were pretty much on key, but there were always a handful of musical strays. It really didn't matter because just the sound of all those voices singing together always hit the audience right in the heart.

If we are resistant to singing the dirge, it's probably our egos getting in the way. Let's remember that it's about the candidate and not about us. The song itself is really easy to sing, only eight notes, and all within an octave in a very singable range for most voices.

In an effort to encourage the brethren to sing Pleyel's Hymn, I have put together an accompaniment recording for you to use. All it requires is a CD or MP3 player and one brother to push the start button – easy. There is also a lead sheet with just the melody and chords, perfect for guitar. I bet most lodges have a brother with a guitar!

So c'mon, fellas, let's put this song back in the degree!

#### Recordings & Recommendations of Some Music for Your Lodge

There are no set rules about the use of music during lodge meetings. In general, music should not interfere with spoken words. One brother should oversee selecting the music and fading out the selection at the appropriate time. These selections have been used effectively in New Mexico lodges and are recommended for your use. Except for *Amazing Grace* and Samual Barber's *Adagio For Strings*, these pieces were composed by Brothers.

#### **Before Opening**

Any selection 1-7. While this is often a time for conviviality, final preparations, and finding a seat, having dignified music playing in the background can set a proper tone of the opening. Consider processing into the Lodge with soft lighting and music.

#### Attending at the Altar

*Finlandia, Amazing Grace, Ave Verum Corpus* (use different selections for opening and closing) *Amazing Grace* (#10) and the instrumental version of *Finlandia* (#8) should be the right length for the Senior Deacon to complete his duties and return to his station

#### **Preparation Room**

Samuel Barber's *Adagio For Strings* (#11) – this selection runs 8 minutes and is followed by Sibelius *Andante Festivo* (#12) for an additional 4 minutes. If the candidate hasn't knocked at this point, any selection 1-6 is appropriate. Don't go to *Pleyel's Hymn* (#13).

#### Processionals, Collecting the Word

Any selection 1-6.

#### The Dirge (Pleyel's Hymn)

This is an accompaniment track to be played as the brethren are in funeral procession in the second section of the third degree. There is a brief piano introduction followed by four verses. Also in this folder are pdf files of both the original choral arrangement and a simple lead sheet (melody and chords). There are two on each page so that it can be copied and cut in half. Each brother should have a copy for the procession.



On February 26, a significant event unfolded at Sandoval Lodge — a 55-year pinning and Fellowcraft Degree. Despite anticipating a bustling evening with the FC Degree, EA Proficiency return, Nico's Food Truck, and the usual lodge activities, WM Davin Teague received an unexpected call from the Grand Lodge of Florida. They requested a courtesy 55-Year Pining for a member, Brother Warren, residing in New Mexico.

Though our Visitor initially intended to collect the pin and certificate and head home, the Lodge persuaded Bro. Warren to stay for our Stated Communications. MWB Dan Irick conducted a touching ceremony, bringing tears to the Brother's eyes. Freemasonry had been a cherished family tradition, with his father and grandfather being Masons before him.

The ceremony concluded with WM Davin pinning the 55-Year Pin on the Brother, escorted out by Junior Deacon Bro. Jonathan Muniz to take his wife home. This marked the beginning of Bro. Fraternal Greetings Brethren! This volume of A Traveling Man Report comes from Phoenix, Arizona where fellow New Mexico Brother Jeffrey Russ (Sandia Mountain Lodge) and I, had the honor of receiving the Super Excellent Master Mason Degree from the Grand Council of Super Excellent Masters of Arizona on Saturday February 24th.

The SEM degree is the third of the Cryptic Mason degrees in York Rite, which is rare in most Jurisdictions and is very difficult to put on since it requires 25 performers and about 2 hours. The first two degrees of Cryptic Masonry, which follow the Royal Arch Mason degrees, are the Royal Master and Select Master, which tell a continuation of the story of King Solomon's Temple. They are fascinating degrees and I highly recommend them to anyone who enjoys the stories and lessons of Masonry.



The Arizona York Rite Masons also performed the preceding two Council degrees on the same morning with about 20 candidates so, it was a pleasure to see how Arizona performs these degrees. Previously, I have only seen them perform one of the Royal Arch Degrees at the Annual Four Corners Royal Arch Festival, where New Mexico, Arizona, Utah, and Colorado all meet to perform the four Royal Arch degrees. The Arizona York Rite Masons did a great job and it was thrilling to see the minor differences in the way they perform, especially with 31 of us candidates for the SEM.

#### Ready As We Are to Receive

Communication and Perspective are the Keys to Understanding.

I have the privilege of being one of the instructors in a Masonic leadership program. Last night I heard that someone commented that they were disappointed that the references used in our curriculum were dated (circa late 20th, early 21st Centuries). My response in the conversation was that I usually start off each class with something very like "our references are meant to relate your training to authors and publications that are found in corporate training, but you can find everything we teach within our ritual and the scriptures." An unfortunate circumstance is that our society is focused on instant gratification, the latest trends, and being fed what to "understand" rather than finding out for themselves what they can about a topic and coming to their own conclusions.

Relating to others is an art, but there is some science. We should always keep in mind that what is communicated is what can be taken by the person to whom we are speaking. They may have a filter in the form of a belief, argument, or lack of interest. They may hear, but they might not be listening; further, they could be listening for something that can be argued. This is ok. You don't have to convince everyone of everything, and you may not have the benefit of their experience – which could change your understanding.

Where you can take the helm is how you receive. This doesn't mean that we should change our mind every time someone else is speaking, but rather that we can always learn something either about the topic, the person, or the circumstance. More to the point, it means that we example respect for the person regardless of whether we agree with an opinion, already know what they are conveying, or have no real interest in the topic.

Think of it this way, when you were a kid and told someone that 2+2=4, did you like the response "of course it is" or the one that said "hey, I think you're right, good job!" This doesn't change, we always like encouragement.

Please consider sharing what you do with all of us – it may inspire greater and more activity in Masonry in NM!

We look forward to helping you share all the things you're doing to help Masonry and your Lodge or group grow!

## Biography of M:W:B: Thomas Lee

Born March 28th, 1966, in San Antonio Texas, to parents Robert and Andriette Schenk, he has one younger sibling, a brother named Robert Schenk II.

Growing up in San Antonio, Thomas attended Theodore Roosevelt High School, where he graduated in 1984, after a short stint in the Navy, he immediately began a career in the construction industry as a heavy equipment operator, and then gravitated towards high-work framing, which he enjoyed most. This began the passion for house design, lay-out and then the total construction process.

In 1983, at the age of 17 he met a young lady named Shirley Dallas Smith (15), whom he later married in 1986, they are still together today after 41 years. They planted their roots in the Texas Hill Country where they began to build the first of many houses that they would call home.

The couple had three children, Justin 22 (who passed away in 2009), Wesley 34 and Kayleen 27, and two amazing grandchildren.

In April of 2000, Thomas knocked on the door of Freemasonry, and it was opened unto him, having been Entered, Passed and Raised in Bandera Lodge No. 1123, Bandera Texas, and eventually served as Worshipful Master in 2007.

In 2004, the couple moved their family to Ruidoso, New Mexico, where they established Arquette Construction, a company named after Thomas' grandfather who taught him all the basic skills needed for home building, he immediately went to work, acquiring residential lots, and building spec houses to sell, and custom homes for clients. During his first three years in New Mexico, with Bandera Lodge backing him, Thomas travelled monthly, sometimes twice, back to Bandera, Texas to meet his obligations as an officer in the Lodge, and eventually Worshipful Master in the East. During that time, he also visited Ruidoso Lodge No. 73, and ultimately joined because it felt like home. The Lodge immediately put him to work by appointing him Senior Deacon, and through the years there, he would serve as Worshipful Master in 2010, 2014 and 2017.

In 2011 he was appointed District Deputy Grand Master by Most Worshipful Grand Master, Bobby Arther, and served in 2012 under Most Worshipful Brother Josh Lightle in the same capacity.

2013 saw him appointed District Deputy Grand Lecturer by Most Worshipful Bill Childers, who would eventually become his masonic grandfather by appointing Right Worshipful Brother Adam L. Hathaway Junior Grand Deacon that same year.

Five years later in 2018, RWB Adam L. Hathaway would be elected Grand Master of masons of New Mexico, earning him the title of Most Worshipful Brother, and in doing so, appointed Thomas L. Schenk to the Grand Lodge line as his Junior Grand Deacon.

Over the next five years Thomas was appointed to Senior Grand Deacon by Most Worshipful Grand Master Ralph A. Easley, and then would eventually stand elections for both the Junior Grand Warden and Senior Grand Warden positions, and ultimately Deputy Grand Master, serving under Most Worshipful Brother Bill J. Pogue, Grand Master 2022.

One of the first duties as Grand Master, Thomas appointed Right Worshipful Brother James Bungard of Dona Ana Daylight Lodge No. 78 as Junior Grand Deacon, carrying on that time honored tradition of adding to

In 2023, Thomas was Installed as Grand Master of the Most Worshipful Grand Lodge of Free and Accepted Masons of New Mexico and serves in that capacity to this very day.

One of the first duties as Grand Master, Thomas appointed Right Worshipful Brother James Bungard of Dona Ana Daylight Lodge No. 78 as Junior Grand Deacon, carrying on that time honored tradition of adding to their masonic family lineage.

To travel as a Grand Lodge Officer and have the time for family, Thomas has stopped building homes, and now maintains the properties of all his customers over the past 20 years. He says that it is like having an unlimited supply of "Honey Do's" that will keep him busy for eternity. However, he states that there are still a few houses left in him that he would like to build before he retires and hangs up his tool bags!

## Grand Masters Address

To the Brethren of the Most Worshipful Grand Lodge of Ancient Free and Accepted Masons of New Mexico, Good morning,

I want to welcome you to the 147th Annual Communication of the Most Worshipful Grand Lodge of New Mexico, here in the beautiful village of Ruidoso, New Mexico. I hope that each of you and your families are having a great and memorable time. Our host, The Inn of the Mountain Gods wish the same. Thank you for making the trip and taking part in our annual celebration and supporting our Fraternity.

I would especially like to thank our visiting Brethren from other Jurisdictions for being here, you are truly Travelers of the Craft. Finally, let us offer a special thanks to all our spouses, families and friends who stand by us and support all that we do. If not for them, it would not be possible.

So please sit back, relax and enjoy what Ruidoso, The Inn of the Mountain Gods and the Sacramento Mountains of Lincoln County New Mexico have to offer. Rekindle old friendships and feel the warmth of new ones... most of all, rest and relax.

On April 14th, 2000, I knocked, and the door of Freemasonry was opened unto me. During the event-ful ceremony of initiation, I was told that one day "even the purple of our Fraternity may rest upon your honored shoulders". I can honestly say that thought has always been the furthest thing from my mind. I just wanted to get through that evening, gather my belongings, and go home. Throughout the next day, all I could think of is what have I got myself into.

As time went on, I found myself being drawn to my Lodge, and wanting to be around those in attendance. The Masons who took me in seemed so knowledgeable and were always as ready to give as much as I was willing to receive. One man stood out, and not only did he become my coach, but he also became my mentor, my masonic idol if you will. I would be remised if I did not mention him in this, my Grand Masters Address. WB Warren Wheeler of Bandera Lodge No. 1123 in Bandera, Texas, not only taught me the ritual, but he also taught me all the how's and why's of Freemasonry.

Brother Warren and his wife Doreen were ranchers, and between their two families they had thousands of Texas hill country acres. The two of us would climb into his pickup every other afternoon and drive the various pastures and I would learn the ritual. Most Saturdays Doreen would pack us lunch and we would head out early, at times it would take hours to cross that ranch, idling along in that old green Ford, going over our masonic work. On occasion another brother would ride with us, and we would take turns practicing. He would learn a part in a degree, or go over a conferral, then I would recite my proficiencies. This practice would go on for months, one Degree at a time. Every trip we would return to the house and Doreen would ask, "how did it go?", and Warren would say "good, but he is not quite there yet, needs a little more practice".

One Sunday after driving the ranch, we returned to the Wheeler house, dinner was ready, and Doreen invited me to stay just as she had always done before. Warren went to wash up, then stepped outside to have a quick smoke. It was then that Doreen let me in on a hidden secret. She told me that she heard that I was ready to turn in my Master Mason proficiency months ago, and that the only reason Warren was taking his time was because he wanted somebody else to have to open all those gates at the ranch, instead of him, and that it didn't look like he was going to have another candidate for quite a while! Regardless of what she said, I never told him, I just enjoyed our rides.

Warren is long gone, and so are all those other brothers who rode with us, but their memory, and the times we had live on in my thoughts. It is through those kinds of close fraternal relationships we build the ties that last a lifetime.

Since moving to New Mexico, I have been able to build those very same relationships. Freemasonry is a universal language and a way of life. Over the past twenty years the Masons of New Mexico have given me the same knowledge and opportunities that I received in the front seat of that old pickup. In fact, more. In Texas, with a membership so large, I felt like a number. In New Mexico, here, we all have a name. Since the first time I walked through the door of Ruidoso No. 73, the first time I attended a New Mexico Annual Communication, and to this very date, it has felt like home, and I am forever grateful.

I stand here before you as Grand Master, not because of my accomplishments, but because of yours. Each one of you has taken the time to shed light to a brother who was simply seeking it. You have taught me what it is to be a Freemason and I hope I have lived up to your expectations. This past year, and the years before having been the most rewarding challenge I have ever faced. I will always carry those rewards with me, even if I am called to that Spiritual Building above.

## Thank you all for giving me that opportunity.

I am also saddened to report the loss of MWB David Lance Baker, Past Grand Master of the Most Worshipful Grand Lodge of Ancient Free and Accepted Masons of New Mexico, 2009.

Brother David passed peacefully at his home in Belen, New Mexico on Saturday March 2nd, 2024.

His gentle soul and presence will be greatly missed.

### Ritual

This past year more emphasis was put on the duties of the District Deputy Grand Lecturers. It was determined early on that they play a vital role within their respective districts. Each of them was tasked with the responsibility of collecting as many ritual sections as possible to help build a database of qualified Ritualist within each of the (8) eight districts thus providing both leadership and a wealth of ritual knowledge that all Lodges of the new District layout can draw from. With the result of Lodges being able to better perform their own ritual work, and utilizing their own members, and not having to rely as much on the Grand Lecturer for continual support.

274 Masonic Ritual Sections were turned in during the 2023-2024 masonic year. Please see the Grand Lecturers Annual Report for a detailed accounting for each District and Lodge.

Two of our brothers received their first Blue Cards while another received his ninth, one more and this man will be a Life Lecturer.

At the time of this report, these are the Candidate statistics for the 2023-2024 masonic year:

Initiated Entered Apprentices: 88

Passed Fellowcraft: 49

Raised Master Masons: 32

36.36% of initiates were raised to the Sublime Degree of Master Mason while the other 63.64% are still in que waiting to progress.

With the addition of the Grandview Data System, the Candidate Leads Sheet, and the Education Programs that are associated within the Grandview Data System, both our candidate and retention numbers are already showing improvement and are predicted to steadily increase once the system is completely up and running. Lodges are encouraged to take complete advantage of what is now being offered and use it to the point of considering these just more "working tools" at their disposal.

## **State of the Craft**

Almost two years have gone by since having to endure all the trials and tribulations of that dreaded "C" word.

I'm talking about Covid-19, something that I hope we never have to experience or talk about again. At first it was thought that there would be a negative lasting effect on our Fraternity, especially here in a Jurisdiction the size of New Mexico. But, in fact, here at home it has been just the opposite. During that time, we were all encouraged to get the "shot" to better prepare ourselves for what may lie ahead. Turns out that virus invariably was the shot in the arm that freemasonry needed. In New Mexico it was like hitting the "Reset" button. The enthusiasm with which our brothers returned to their Lodges was miraculous. The current state of morale, participation and the eagerness to step up and serve is to be commended. Every mason here in New Mexico is solely responsible for that happening. Thank you for all your efforts, we are here because of you.

Covid also gave us the opportunity to look within. Not just through personal reflection, but the chance to look at all aspects of our organization while we were idle. The leadership during that time began the process of turning over every stone to help identify our weaknesses, our strengths, and where we can make improvements.

It has become the incumbent duty of today's officers to carry on that tradition. Those before us prioritized their battles and were victorious in their siege. Our hope is to conquer as well.

During the 2023-2024 masonic year our battles were taking on the task of implementing a new data storage system, re-districting an entire state and most importantly, addressing the continual financial hardships that we have experienced over the past few years. It was noted early on that there were shortcomings within our various investment funds. This too was one of those challenges we faced this year. The Investment Advisory Committee, the Grand Treasurer and I continually met with our investment broker, Charles Schwab, to keep up with today's market. All the while feeling confident that we were making money, and not losing it. This was the case; we just weren't getting the higher yields needed to fund certain items such as the Endowment Fund. The officers of the Long-Range Planning Committee immediately went into action to see what options were available to remedy this situation and develop a better financial plan. It was discovered that we have been working from a financial strategy that was put in place years ago to protect the Endowment Fund and keep the principal whole. This is a mid to low-risk investment coupled with having a broker who works off a flat rate fee rather than a percentage commission. There is really no incentive to try and do better. Currently we are looking into overhauling the entire investment plan. Our portfolio is being shopped around and several brokers have been discovered that can provide more of what we are looking for. One of which already handles several Lodges, an Appendant body and Masonic Charities. All having great returns. Just keep in mind that with greater returns come higher risks. Long Range Planning will be presenting all the information gathered and together we will all decide what is best for our financial future.

And finally, as of March 1, 2024, (84) of our Brothers are in the suspension for non-payment of dues column and are still considered active until the June 30th deadline. Let's all try to reach out to these men and see why, perhaps all they need is some encouraging words or maybe just a little help.

## **Actions**

Removed Worshipful Master from Office.

In August of 2023, a situation presented itself in which the Grand Lodge of New Mexico started receiving information regarding material posted on social media that was not inline with traditional Masonic beliefs. The subject of this material was perceived as religious/anti-religious in nature and was found by some to be offensive. The author of this material clearly stated publicly and online that this was of his own opinion and was not that of his Lodge or Grand Lodge.

However, once it was posted the subject matter was then public knowledge. It quickly became the duty of the Grand Master and Grand Secretary to answer these calls and diffuse the situation. To have acted rash or hurriedly in our decisions could have caused further damage or embarrassment to the name and reputation of the Grand Lodge of New Mexico, and to those involved.

Rather, a calm, systematic approach was initiated. One that involved careful investigative efforts, one that took all the factual evidence into consideration, and one that followed our masonic law including our obligations as Master Masons.

First it was established that even though this information could be perceived as offensive, it was in fact the "author's" - 1st Amendment Right under Freedom of Religion and Freedom of the Press to publicly state his own views and opinions.

Through our own investigations we found that there was in fact information on the brothers own "personal" social media Page/Account regarding his views of religions that he and others follow, and if practiced, there could be an accepted individual belief within our Fraternity that one could consider their own choice of deity as their "supreme being". Of course, this caused an uproar within the masonic world... it does go against the very grain of our masonic principles and teachings, or does it?

Even though I don't personally agree with this, I had to look at the situation through our brothers' eyes to try to understand it. As Grandmaster, I had to remain neutral to allow the scales of justice to work.

As Grand Master my first duty was to answer all the concerns and protect the name and reputation of the Grand Lodge of New Mexico. Secondly, I felt that we needed to distance ourselves from the situation and remove all public likenesses relating to the subject by removing this brother from our website to allow things to settle.

As things started to calm down, I met with the Officers of the brother's home Lodge and began discussions on how they wanted to proceed to remedy the problem.

The Lodge stated that they wanted to have a meeting with the brother in question to discuss their options and come up with a solution that would not bring further embarrassment and harassment to the Lodge.

Their main objective was to maintain peace and harmony amongst its members and do what they felt was best for Freemasonry.

After offering counseling to the brother, and pointing out the magnitude of what had happened, the brother then realized what had transpired from his post on social media and offered to step down as Worshipful Master, stating that he never intended to harm the Lodge, and felt it was in the Lodges best interest in moving forward. The Lodge agreed, however our bylaws under Code. 180, do not allow an officer to resign or demit while in office.

<u>Code. 181</u> states that for good cause shown, the Grand Master may remove any officer of a constituent Lodge. In the event of removal, dispensation may be granted, without charge, for the election or appointment of a successor to fill vacancies thus created. And that is exactly what happened.

The Lodge felt that it would be in their best interest to have the Senior Warden move to the East and have a Past Master pro-tem the Senior Warden position so as not to disturb the order of the progressive line, and I agreed.

Although there were legitimate complaints logged with the Grand Secretaries office, it was later determined that a vast majority of the complaints were bogus and submitted by impostors.

Through cross referencing our evidence it was discovered that many of the callers didn't even exist in the jurisdictions they were calling from, and even fake social media accounts using false aliases were being set up on Facebook to post to the home pages of New Mexico Lodges to spread negativity. These men simply did not exist. It was also discovered that all the attention focused on this individual was made to have him kicked out of Freemasonry and removed as a social media influencer due to him having such a high number of followers. Social media pays influencers monetarily based off the number of subscribers and followers one has. Well, the plan partially worked, and now the very same thing is happening to other Masons across the country all because of varied opinions on subject matter, and out of pure jealousy.

Moving forward, this brother has been reminded in the most tender manner of his failings by his Lodge, and they have aided in his reformation, and since then he has since done everything possible to maintain peace and harmony not only for his Lodge, but for Freemasonry as a whole.



This year I have chaired the Long Range Planning committee and served on the Grand Lodge Board of Directors. The LRP has been working on how we can make our Endowed Membership program work better.



# Long Range Planning Committee Re-

Most Worshipful Grand Master, Grand Lodge Officers, Worshipful Master, Lodge Officers, and Brethren.

The following is the report for the Long Range Planning Committee for the year 2023.

The committee members are RW James E. Bungard, RW Philip A. Christophersen, RW Robin K. Justice (Committee Chairman), RW David L. Baker, RW Alexander M. Cosby, RW Kevin L. Fitzwater, and MWGM Thomas L. Schenk.

The committees focus this year has been on the Grand Lodge Endowed Membership fund and issues that continue to prevent it from adequately meeting the needs of constituent Lodges and their members. Discussions with Lodges and the membership have raised concerns about the performance of the fund and its impact on Lodges.

As it is structured now, the Endowed Fund cannot meet the financial needs of the Lodges of the State of New Mexico. Many Lodges are heavily dependent on the payouts for their operating budgets. The payouts are frozen at the dues and Grand Lodge per capita in effect at the time the endowed membership was purchased. They will always be behind the rising costs of maintaining our Lodges. The cost of running the Grand Lodge is also going up. If Lodges raise their dues, an inordinate portion of the operations falls on the non-endowed members of the Lodge. The same occurs if the Grand Lodge raises the per capita to meet rising expenses.

At the annual November Grand Lodge budget meeting the committee presented its findings and recommendations to the membership. It was a well attended meeting and a very informative discussion took place with input from many attendees.

There were many ideas for what can be done to correct the situation we continue to find ourselves in. One was to do nothing, wait for the market to recover, and basically hope that the situation will not occur again in the future. This option is "kicking the can down the road". It does not address current shortcomings in the program and will only make things worse in the future.

Other options were presented. All of them will require changes to the Constitution and by-laws of the Grand Lodge. Many are short term fixes, and some basically propose ending the program in a way that will return the monies to the purchasers. All options have plusses and minuses.

A long term solution is what is required. We cannot continue to operate as we are now. It is hurting the Lodges and is too unreliable to provide for the Lodges needs. Analysis of how the current program structure is unable to effectively meet its requirements, and proposals for modifications or outright replacement need to be done. Also, analysis of the current investment strategy for the fund needs to be done, and recommendations by Brothers who are knowledgeable in investing and the stock market is essential. The Long Range Planning Committee believes that continued work on the Endowed Membership program is essential to restore financial health to the Lodges. There is no "magic bullet" that will fix the program. Some hard decisions will need to be made.

The Long Range Planning Committee believes that it is extremely important for continued work to be done to develop a real solution to this problem. I personally want to thank the members of the Committee for their contributions to the work we have done.

# Junior Grand Warden's Report R:W:B: Kevin L. Fitzwater

Brethren,

Another year of Masonry has passed. Grand Lodge Officer reports often are lists of lodges visited and evets attended. I would like to approach this report a little differently.

In my travels about in the state I have come to appreciate the state of Freemasonry even better. I was welcomed warmly everywhere and, even when discussions involved issues of dispute or disagreement, it was never less than brotherly. I have seen a revival in some lodges that have recently languished, and I commend the brethren and their leadership for that. Although there will inevitable be the closure of some lodges and the surrendering of charters in the future, and the consolidation of others, my impression is that Freemasonry in New Mexico is strong. And I have reason to believe it!

I my travels to other grand lodges at their annual communications, I have on occasion sadly witnessed incidents of disharmony and tense conversation concerning conduct and responses to that. I need to be clear that the brotherhood in these jurisdictions is very brotherly, please do not get me wrong. But I have developed an appreciation for how our jurisdiction has approached the inevitable conflicts that arise. Our fraternity is a great one, the best mankind has produced, but it is still a human one. My respect for the leadership of the lodges and their wise and sensible governance has only grown. I am so blessed to be a brother in this great state!



## Grand Secretary's Report

#### Brethren,

WOW, what a ride! First, I want to thank the lodge secretaries for their support and understanding as I waded into this new job. I also want to thank MWB Tom Schenk and the other Grand Lodge officers for their patience and the encouragement they gave me this year. I would like to also thank WB Len Roughgarden for all his help with the "technology" involved with this position. He has been invaluable in getting and sometimes keeping me out of trouble with computers, printers, and all manner of technology-related issues. I knew this was a tough job when I agreed to run for the position, but it has proven far more diverse and complicated than I had ever imagined. I've equated it as being like "trying to count the leaves on a willow tree in a windstorm". There are so darn many moving parts and they are always in constant flux.

To start off I had a goal to put out a "Proceedings" for the 146<sup>th</sup> Annual Communication in Farmington. It hadn't been done for a few years and I remembered receiving them during the years that I was a lodge secretary at Temple Lodge No. 6... and promptly putting them on the shelf with all the others from years gone by. I didn't know just what went into producing one. I finally got one (my version of one) out in about November... better late than never.

I was also informed after my installation that I would be responsible for doing the 990s for most of the lodges in the state. Being unsure just what a 990 was and having no idea how to do or file one I started this task. As with many of the parts of this job, it's figuring out how as opposed to actual doing that is the hardest part of the job. Once I found the file of postings from the previous year and tracked down the password to the state website it went pretty smoothly.

Of course, the big event, for all of us, was the anticipated transition to Grand View Systems. After many anticipated "Go Live" dates came and went we finally pulled the band-aid off and jumped in with both feet on August 1st. I was optimistic about the new database program and while it came with its own bumps in the road, the transition has gone very well and even the most skeptical users are adapting nicely to the features that it offers... and there are more of those to come. We are now out of the "Background Check" business and the lodge secretaries can order their own background checks and not have to collect payment for them and send it to the Grand Lodge. Online dues payments are now up and running and that opens options for our members.

We've had our first experience with doing the "Annual Return" online and I'm amazed at just how easy it is. We still have a few lodges that have not filed them yet but we're getting there, and even the most tech-challenged in our ranks are doing a great job with the new system. It has been a learning curve but I'm more impressed with the Grand View System every day.

We went back to a "5-up" dues card system and while, due to time pressures to get them out to the lodges the final edit was skipped, the new cards do require the members to brush up on their scissor's skills to make them more conducive to your wallet I think they came out pretty well. In the future hopefully we will have the option of changing to a digital dues card that will live on your cell phone.

As many of you know I'm big on photos and have been pushing for everyone to get their photo uploaded to the new database. It's very easy and may add additional security to our dues card system in the future. Dealing with member's names day in and day out, it's nice to have faces to go along with the names.

My travels this year have included the Rocky Mountain Masonic Conference which was held in Las Vegas this year. It was very interesting and a great chance to meet the officers from our neighboring jurisdictions and hear their victories, concerns, ideas, and solutions to many of the same challenges that we face here in the "Land of Enchantment". I also attended the Grand View Conference in Shreveport, LA just as we "went live" with the new system with the hopes that I could get a head start with the learning curve. The other attendees were already using the system, many of them for several years, so my learning was somewhat limited but the contacts I made and the ideas that were exchanged were invaluable, and as well, the energy and enthusiasm they all showed for the Grand View System were inspiring. If you don't have the knowledge, at least seek out the people that do! Finally, I attended the Conference of Grand Masters and Grand Secretaries, this year held in Seattle, WA... they should really pay their "Sun" bill as it was very cloudy and rainy at this time of year, but again the information discussed, and the contacts made were well worth the trip. We're facing many new trials in our lodges, but it was enlightening to find that they are everywhere, and solutions are not as out of reach as we may think.



## Grand Lodge Board of Directors

## **April 4, 2023**

A general Board of Directors meeting was called, and it was reported by RWB David Baker/Grand Treasurer that the Investment Advisory Committee was going to have a Portfolio review with Charles Schwab at the next Investment Advisory Committee meeting. There was a vote taken to cover a small, short fall reported by the Annual Communication Committee relating to the 2023 Annual Communication. The amount was approximately \$ 2200.00. It was approved to cover the expense.

## August 6, 2023

The 2<sup>nd</sup> quarter Board of Directors meeting was called to discuss converting to Grandview Data Systems and if there were any costs. It was stated that there was no initial cost, and the Grand Lodge of New Mexico would not start being billed until the 2024-2025 Annual Budget cycle due to the problems associated with the coding differences caused by the Groupable/Mori data uploads.

The Grand Lodge of New Mexico also received a certified letter from Groupable/Mori stating that we did not own the electronic information that they were storing, and that we did not have permission to share it with any other agency based off a renewal contract dated February 2023. It was determined that no such contract was ever signed, and that we had already sent them a certified letter that we were terminating their services as of August 31<sup>st</sup>, 2023. No other actions regarding this situation have been presented to date.

Endowment Fund strategies were discussed due to market fluctuations, and it was brought up that we are not in the position to move our investments as needed to keep up with trends because of the restrictions within our bylaws concerning the Endowment Fund. Legislation will have to be brought forward and discussed with the Lodges and changes put into effect. Long Range Planning will be looking into all possibilities and present them in the future.

It was also noted that the Grand Lodge of New Mexico incurred debt the previous year to make Endowed payouts. The subject of where the funds were borrowed from and how they were going to be paid back is a top priority.

The Board of Directors was given an update regarding the Mueller Estate and Wiggins Estate cases that the Grand Lodge of New Mexico is involved with. The Mueller case involves an estate left to the Grand Lodge of New Mexico. We were advised by our attorney that the property had been sold by the family and the proceeds were used for the elderly care of Mrs. Mueller and there was no reason to legally pursue this case any longer.

The Wiggins case concerning the Masonic Cemetery in Hagerman, New Mexico, and the perpetual care of masonic graves was still waiting for initial judgments to be made in court. We are still waiting for updates.



## Board of Directors (Continued)

### **December 3, 2023**

It was brought to the attention of Grand Lodge months earlier that Feliz No. 29 was considering surrendering their Charter and donating all their assets to charity. If approved by the membership to close Feliz lodge, they would also be purchasing all its remaining non-endowed members' endowments. This action would be in the estimated amount of approximately \$ 115,000.00. It was noted that this would have an impact on the fund.

Feliz No. 29 was also seeking permission from the Board of Directors to donate their property and building to the city of Hagerman, and to also comply with the Constitution and Bylaws of the Grand Lodge of New Mexico concerning Lodge property, as a show of good faith to Hagerman to avoid the cost of trying to sell the building due to environmental issues, and code violations. Due to the value of the property and the cost of renovations the Board of Directors voted to allow Feliz No.29 to proceed with their intentions.

## **January 11, 2024**

On December 31<sup>st</sup>, 2023, as per **Code.62 (4),** it was reported to the Board of Directors that the Endowment Fund had not earned enough for a Lodge payout. The numbers reported as of 12-31-2023 that there was an available earning of \$48,000.00. This amount is a 3% earning based off a 1.6-million-dollar principle.

The Board of Directors taking into a consideration a partial payout to the Lodges and considering the "loan" that was made the previous year to pay the Lodges in a situation that should have also been a partial payout as well, it was decided that the best course of action would be to follow our code concerning the Endowment Fund and meet our fiscal responsibilities.

Many scenarios were considered, some involving a partial payout to the Lodges and a partial loan payment over the next few years based off earnings. Ultimately the Board of Directors decided it was in the best interest of the Grand Lodge of New Mexico to meet its debt and live within its means.

The Board of Directors, Investment Advisory and the Long-Range Planning Committee all agree that it is time to investigate other investment strategies, re-structure the Endowment Fund, or change the Code restricting how it is handled. Either way it was stated that there are associated risks with any plan.



## 2024 Annual Report

## Most Worshipful Grand Master:

Your committee is responsible to verify that the Grand Lodge requesting recognition is, in fact, operating in a regular manner, per our Basic Principles, which are as follows:

#### **Ancient Landmarks**

Monotheism (i.e., a belief in the G.A.O.T.U. [Grand Architect of the Universe]).

All Initiates in lodges under a Grand Lodge take Obligations on or in full view of the Volume of the Sacred Law (Bible, Tanakh, Qur'an, etc.).

Furniture of the Lodge—The three great Lights of Freemasonry (namely the Volume of the Sacred Law, Square, and Compasses) are always exhibited when a Grand Lodge or its subordinate Lodges are at work—the chief of these being the Volume of the Sacred Law.

Prohibition of the discussion of Religion and Politics—A Grand Lodge recognizes and believes that the dominant purposes of Freemasonry are charitable, benevolent, and educational. Discussion of sectarian religion and partisan politics is strictly prohibited from all activities under its auspices

The membership of a Grand Lodge and individual Lodges is composed exclusively of men (i.e., a fraternity); no Masonic relations are had with mixed lodges or bodies, which admit women to membership.

**Legitimacy of Origin**—All Regular Grand Lodges, must be chartered by a regular superior Grand Lodge (e.g., the Grand Lodge of New Mexico was chartered on 06 August 1877 by four Craft Lodges under the jurisdiction of the Grand Lodge of Missouri).

**Territorial Sovereignty**—A Grand Lodge has sovereign jurisdiction over the Lodges under its control. It is a responsible, independent, self-governing organization, with sole, undisputed, and exclusive authority over the Craft or Symbolic Degrees (i.e., Entered Apprentice, Fellowcraft, and Master Mason). It is not in any way subject to, or divides such authority with a Supreme Council or other Power claiming any control or supervision over these degrees; and it does not extend its authority into, or establish lodges in a territory occupied by another lawful Grand Lodge, without expressed consent of said Grand Lodge.

The Committee has endeavored to ascertain that the foregoing principles have been strictly adhered to in recommending recognition. In addition, your Committee has independently researched and compared the following Grand jurisdictions to the judgements decided by the following entities:

Commission on Information for Recognition—organized in 1951 as a facility to gather, collate, and revise information on Grand Lodges in other lands, as a service to the Conference of Grand Masters of North America; the Commission neither advises nor recommends that recognition be given to any Grand Lodge, but merely indicates whether or not it considers that a Grand Lodge in question satisfies the conditions of regularity.



IN 2018 THE GRAND LODGE OF NEW MEXICO ADOPTED AN INVESTMENT POLICY WHICH PROPOSED "...A MODERATE RISK TOLERANCE" WITH ITS FUNDS. IT ALSO SET OUT A PLANNING HORIZON OF 5-7 YEARS, OF WHICH WE ARE APPROXIMILTY HALF WAY. THE POLICY ALSO SUGGESTED A LONG TERM RATE OF RETURN SHOULD BE 5.7%


SINCE THE 2020, WHEN THE INVESTMENT ACCOUNT WAS PLACED WITH CHARLES SCHWAB & CO., THE GRAND LODGE FUNDS HAVE SEEN AN OVERALL 6.7% INCREASE IN THE PORTFOLIO.

CALENDAR YEARS 2022, AND FOR THE MOST PART, 2023 WERE UNDER PREFORMING AS DID THE OVERALL MARKET. THE LAST QUARTER OF 2023 AND SO FAR IN 2024 THE PORTFOLIO HAVE DONE WELL.

## Grand Lodge Audit Committee

Most Worshipful Grand Master, Officers, and Brethren,

On March 4, 2024, the Audit Committee reviewed the books of the Grand treasurer, RWB David Baker, and the Grand Secretary, RWB Tony Christophersen at the Grand Lodge in Albuquerque, New Mexico. The audit committee took approximately two hours and reviewed the documents consisting of:

Monthly Bank Statements from New Mexico Bank and Trust

Monthly reconciliation statements from QuickBooks maintained at Grand Lodge

Documentation justifying the transactions in the bank and reconciliation statements, e.g.:

Receipts for reimbursed expenses

Spreadsheets for calculating payments to lodges

Other Documentation as appropriate

The Grand Lodge maintains a total of seven checking accounts, all at New Mexico Bank and Trust. All the bank statements and reconciliation statements for each account are neatly filed in separate sections of a large binder which, after the audit, was stored in the files of the Grand Lodge. The documentation is clearly labeled with the check number of the reimbursement making it easy to connect the expense report with the payment.

The audit committee appreciated the neat and orderly records kept by the Grand Secretary and the Grand Treasurer. The system is clear and well maintained and facilitates a quick and easy audit. The Grand Secretary and the Grand Treasurer clearly have a good system in place.

The methodology used in the audit was a cursory look at the transactions and documentation of the bank accounts used by the Grand Lodge and not an exhaustive account of every transaction. Payments from the checking accounts were selected for attention by the committee and an explanation for the payment along with justifying documentation was requested.

In conclusion, the Audit Committee reports a favorable audit with no errors or inappropriate transactions found. The committee found a good, we'll-maintained, accurate and easily understandable system for keeping track of income and expenses and encourages future Grand Secretaries and Grand Treasurers to continue the care and attention to detail displayed by RWB Tony and RWB David.

# Grand Historian Report W:B: Tyler R. Anderson

Most Worshipful Grand Master,

Events within my family required that I take a step back from many of my activities as Grand Historian this year, and so my productivity was perhaps somewhat lower than I would have liked. However, some good work was still achieved and I feel a way is paved for some ongoing projects which will be of great benefit to this Jurisdiction and its members.

Most of my work in the latter portion of the year has focused on the historical Lodge records. One by one the folders are being opened and organized. Documents and objects of particular interest are being scanned into digital format, and transcriptions of handwritten documents are being made. Many of our most fascinating documents, particularly before the First World War, are in old cursive—beautiful and appealing, but also very difficult to read! By transcribing these old pages, we can make significant tranches of our history available and approachable for the curious membership.

The transcriptions are also being annotated with interpretive information, and a short narrative commentary or history is planned to accompany the digitized files from each Lodge, to help tie documents, events, personalities, and details together. The final product will be a small archive, Lodge by Lodge, which will offer a series of snapshots of our direct Masonic predecessors, their work and history. These can be loaded into Grand View and be instantly and easily available. In many cases, it means that for the first time in over a century, members will be able to see the real thing (or at least good images!) and get a feel for where their own Lodge really started. I am currently working on half a dozen files, and every single one has really interesting stuff in it.

I must point out that the idea for this came from RW Robin Justice, who several months ago suggested that I prepare histories for every Lodge. I smiled and nodded, but in my head I was saying, "That's insane. You have no idea what you're asking." But in late 2023 I decided I might as well play with the idea. What an incredible idea it is. This is going to take a long time, but the work will continue to move forward. (Don't call me, I'll call you.)

As a value-added bonus, as I work through these folders, aging and delicate pages are also being moved into archival enclosures, folders, and supports, which will extend their lives almost immeasurably. These supplies can be a bit costly in the moment, and so I thank the Brothers of New Mexico for continuing to support the budget for my work.

Grand Master Schenk, I offer you my thanks for the opportunity to continue in this work and office. It is, in my mind, the best job in New Mexico Masonry.

#### Most Worshipful Grand Master:


The Information Technology (IT) Committee is responsible for identifying, evaluating, and implementing information technology solutions and supporting the constituent Lodges and individual users who access these technologies. In the calendar year 2023 your IT committee made significant progress in implementing a cohesive framework for technology provided and used by the Grand Lodge.

The 2023 committee consisted of DGM S Almager (Chair), RWB A Cosby, WB L Roughgarden, WB J Huang, WB A Reber, and RWB T Christophersen. Additional technical assistance and support to the committee was provided by RWB D Newhouse, WB S Balke, and WB J Overfelt.

Activities and accomplishments for the committee in 2023

#### 1. Grandview

- a. Migration to the new membership management system Grandview, was begun in the first quarter of 2023 and was rolled out to the Brethren in Q3. The committee estimates that more than 50% of the constituent Lodges are now actively using Grandview as of the date of this report.
  - i. During the migration phase MORI/Groupable was contractually maintained to ensure capture of pertinent events while the Grandview system was being customized and tested.
  - ii. Data was transferred (imported) from MORI/Groupable and the local Paradox database for the final time in December 2023.Grand View is now the single membership database in use by the Grand Secretary.
  - iii. MORI/Groupable and Our Lodge Page (OLP) are no longer active.



## Information Technology Committee 2023 Annual Report

(Continued)

The data uploads resulted in a successful printing of the 2024 Dues cards with minimal Grand Secretary "rework".

The annual returns report was successfully enabled in January 2024. Grand Lodge Internal Network

The current MS-Windows file server role was paralleled with an eight (8) terabyte Network Attached Storage (NAS) unit. This unit will backup and maintain copies of all files currently stored on the existing server and replace it completely at the end-of-life of the server.

External access accounts have been reduced to administrative access/ actions only to further safeguard the network from hacking and malicious intrusions.

#### Cost reductions

Acting on recommendations for reducing expenditures the committee reduced the number of individual Grand Lodge Google eBusiness accounts (...@nmmasons.org) and replaced them with a distribution list which resulted in an annual savings of \$576.

#### Event based technical support

The Grand Lodge IT Committee has provided support to several bodies and events in the form of Zoom meeting scheduling, recording, and streaming (ex: 2023/2024 budget meeting).

When requested the committee has also provided technical support and equipment when required for in-person meetings (ex: 2023 Grand Communications).





## Holdover Legislation from Annual Commu-

#### DECLARATION

We, The Grand Lodge of Ancient, Free and Accepted Masons of New Mexico, in order to for a perfect fraternal union, establish order, insure (ensure) tranquility, provide for and promote the general welfare of the Craft and secure to the Fraternity in New Mexico the blessings of Masonic Privileges, do ordain and establish this Constitution; and provided further, that all resources of the Grand Lodge, both principal and income, may be used for Masonic Relief.

#### Code 43. RITUAL BOOKS AND CIPHERS.

- (a) Only Grand Lodge Ritual Books and ciphers produced under the control and approval of the Grand Lodge shall be used. They shall not be reproduced without expressed approval of the Grand Lodge. Any such cipher shall not contain any Due Forms, Due Guards, Penal Signs, Grips, Words or Passwords. 2012, 2018, 2019, 2020
- (b) Any Mason who is a member in good standing of a constituent Lodge in this Grand Jurisdiction shall be able to obtain a cipher in printed or downloadable digital format for the highest degree which he has received from the Grand Lodge at his own expense. 2018, 2019, 2020
- (c) Ritual Books or Ciphers may not be used in open Lodge or during examination of candidates, however ciphers may be used for instruction of candidates. 2020 2020

#### Code 44. RESPONSIBILITY IN LODGES.

Excluding the New Mexico Monitor and Ceremonies, ritual material in the possession of each constituent Lodge shall be the direct responsibility of the Master for its use, safeguarding, accounting requirements and all related administrative details. The Master shall also have the direct responsibility for ensuring that only approved ciphers are used and only in accordance with Code 43 (c).

The newly elected Master of each lodge shall sign and submit in the Annual Returns (Returns) Packet each year (Code 132) (Code 132) the Annual Inventory and Receipt of Lodge Ritual Books. Failure to do so shall subject the delinquent lodge to a fine of One Hundred Fifty (\$150) dollars. The Grand Master may waive this fine, at the Lodge's request, for cause. Missing or lost booklets (13 total) shall subject the delinquent lodge to a replacement fine of Fifty (\$50) per booklet and/or Six Hundred Fifty (\$650) dollars for the complete set. The Grand Master may waive this fine, at the Lodge's request, for cause.

#### Code 62. GRAND LODGE FUNDS.

#### Code 161. MASTER MAY (SHALL) EXCLUDE.

The Master shall require any Mason to leave the Lodge whose conduct therein disturbs its harmony and may subsequently prefer charges of un-Masonic conduct. 2018

#### Code 172. ELECTIONS AND INSTALLATIONS.

Officers shall be elected by ballot at a regular communication in November or December as specified in the Lodge By-Laws. All officers shall be installed in December at one communication, if possible, preferably on the anniversary of St. John the Evangelist but in no case, no later than January 31. Officers not installed by the time reports are due in the Grand Secretary's office shall be listed on the Annual Returns and shown as not installed. Vacancies resulting from the failure to install by January 31st shall be filled (appointed) by the Master, except in the case of elected officers, who must be elected and installed at the next regular communication following January 31st.

#### Code 191. ADVANCEMENT.

(b) Examination committees shall consist of at least three (3) members (Eligible Master Masons) of the examining Lodge.

#### Code 205, WAIVER OF JURISDICTION Code 205, WAIVER OF JURISDICTION

By unanimous ballot of all members present, determined by black and white balls, a Lodge may waive its jurisdiction over any of its material in favor of any recognized lodge. Should unanimous consent of all members present not be given, the Lodge may not consider a new request to waive jurisdiction until after the expiration of thirty (30) days.

- (a) If the waiver is in favor of another recognized Grand Jurisdiction, all correspondence with respect to such waivers, either granted or requested, must be conducted through the office of the Grand Secretary but it shall not be necessary to obtain the approval of the Grand Master for any such waiver.
- (b) A Waiver of Jurisdiction may be granted to an Entered Apprentice or a Fellow Craft who shall have failed to present himself for advancement as prescribed by our Grand Lodge By-Laws.
- (c) An Entered Apprentice or a Fellow Craft coming from another recognized Grand Jurisdiction, by waiver, must present himself for advancement within the time prescribed by these By-Laws, otherwise he must petition and be elected for the remaining degree or degrees.
- (d) Unearned fees shall be returned to the Brother in the case of a waiver granted to an Entered Apprentice or Fellow Craft to another lodge. 2020 2020

#### Code 369. DEFINITIONS

(a) Lodge Dues are defined as the amount set by the Lodge and paid by a Brother to that Lodge annual (annually) for Lodge operations.

#### Code 370. WHEN PAYABLE.

Dues shall be payable on January 1st of each year, in advance, and any Brother who fails to pay the same within six (6) months from that date shall be dealt with in accordance with Masonic Law. (Code 374) add.

#### Code. 408 EVIDENCE.

- (a) Trial shall be conducted upon the highest degree to which the accused has attained. Testimony of all Masons shall be taken orally in open Lodge.
- (b) Testimony of non-Masons, or of Masons unable to attend the trial, shall be taken in writing by a committee designated for such purpose by the Master or submitted in the form of affidavits. The accused shall be given reasonable notice of the time and place fixed for the taking of any such evidence and have the right to be present and propound questions relevant to the charge.
- (c) The record of a court of competent jurisdiction showing conviction of the accused for the offense specified in the charge shall constitute competent evidence in support of charge. The record of such a court showing acquittal of such charge shall likewise be competent evidence in (on) behalf of the accused.

## Legislation of the 2024 Annual Communication of the Most Worshipful Grand Lodge of New Mexico AF & AM

#### **Resolutions:**

1. Code 61. Annual Budget.

At each Annual Budget Meeting of the Grand Lodge, held no later than November 30 in Albuquerque, the Committee on Accounts, Ways and Means shall present a budget to the Grand Lodge for consideration and approval. Any budget so adopted shall take effect on April 1 of the following year and remain in effect until the following March 31.

The budget shall include allowances for all:

- (a) Salaries
- (b) Travel
- (c) Compensation for clerical assistants appointed by the Grand Secretary.
- (d) Necessary expenses of the Grand Secretaries office.
- (e) Necessary travel and subsistence expenses of the Board of Directors and of standing or special committees.
- (f) Annual one dollar per captia contribution to the George Washington Masonic National Memorial. Such per captia contribution shall be based on the total Master Masons borne on its roll as regular members subject to per captia dues on January 1 of each year.
- (g) Library acquisitions as determined by the Grand Secretary.
- (h) Premiums on official bonds and,
- (i) Any other necessary expenses for the efficient operation of the Grand Lodge activities.

Any Grand Lodge committee requesting funds, other than routinely budgeted amounts, shall submit such requests to the office of the Grand Secretary on or before July 1 preceding the Budget Meeting. 2013

**Rationale:** The George Washington Masonic National Masonic Memorial celebrates the values and integrity of a man who continues to exemplify Freemasonry. Please join 38 other Grand Lodges in honoring his life and symbolizing Freemasonry.

#### **Grand Masters Recommendations:**

#### 1. CHAPTER V – STANDING COMMITTEES

#### **Code 50. APPOINTMENT**

At or before each Annual Communication the Grand Master shall appoint:

- (a) A Committee on Accounts, Ways and Means etc.
- (b) A Committee on Audit etc.
- (c) A Committee on Credentials etc.
- (d) A Committee on Foreign Correspondence etc.
- (e) A Committee on Grand Masters Address etc.
- (f) A Committee on Investment Advisory etc.
- (g) A Committee on Legal Advisement composed of not less than five (5) Brethren all of whom are experienced in appraisal, beneficiaries, bequests, donations, gifts, environment, life insurance, litigation, real estate and wills, to advise and facilitate when needed, to the Board of Directors on such matters as they pertain to the Grand Lodge.
- (h) A Committee on Jurisprudence etc.
- (i) A Committee on Long Range Planning etc.
- (i) A Committee on Masonic Education etc.
- (k) A Committee on Publications etc.
- (1) A Committee on Reference etc.
- (m) A Committee on Ritual etc.
- (n) A Committee on Youth (Masonic) etc.
- (o) A Committee on Annual Communication etc.

Rationale: There is an ever-growing need for such a committee to provide both knowledge and service to the Grand Lodge, as well as to the Constituent Lodges of this Grand Jurisdiction regarding the matters listed in proposed recommendation (g). For decades, Brethren have wanted to leave their Lodges, as well as the Grand Lodge of New Mexico certain "Gifts" to help benefit and perpetuate their existence. Having a legal "Mechanism" in place would allow them to do that, as well as allow their Lodges and Grand Lodge to receive them.

#### 2. CHAPTER 1 – ANNUAL COMMUNICATION

#### Code 1. Time and Place.

The Annual Communication of this Grand Lodge shall be held in the City of Albuquerque State of New Mexico commencing on the third Friday of March of each year at 9:30 am, but the place of the meeting may be changed whenever a majority of the Grand Lodge shall deem such change expedient.

**Rationale**: Annually at the closing Grand Lodge, a motion, second and vote must be had to determine the location of where next year's Annual Communication is to be held. This recommendation would streamline the legislative process and eliminate the need for such action. The outgoing Grand Masters residence, or Annual Communication preference varies from year to year.

#### 3. Code. 365. REQUIREMENT TO VISIT.

Subject to the prerogatives of a Master in regard to the admission of visitors, it shall be the duty of the Tyler, when a visitor has been vouched for by him, or any other member to require the applicant to show a receipt for current dues before the Tyler may admit him into the Lodge Hall. The Tyler shall admit, with the permission of the Master, a qualified visitor hailing from another Lodge in this Grand Jurisdiction at any time during the period he is eligible to enjoy the privileges of membership in his own Lodge. A visitor hailing from another Grand Jurisdiction may be admitted only up to the date of expiration of good standing as applied to Masons in this Grand Jurisdiction. Digital Dues Cards will be accepted from this Grand Jurisdiction, and all other recognized Grand

#### Jurisdictions.

**Rationale:** While the Grand Lodge will continue to distribute annual dues cards, this will allow those who have lost/misplaced their dues cards, to attend Lodge in this Jurisdiction or in others where recognized.

#### 4. Code 393. DUES CARDS.

All categories of members (Regular, Life, Endowed, Primary and Plural) shall be issued an annual dues receipt in accordance with **Code 373.** Lodges desiring to grant a life membership in accordance with **Code 391** shall certify such fact to the Grand Secretary, setting forth the date of birth, date raised a Master Mason, date of affiliation and proof of aggregate total years of membership. Life membership shall become effective upon certification by the Grand Secretary who shall issue a Membership card. Digital Dues Cards will be accepted from this, and all other recognized Jurisdictions.

**Rationale:** While the Grand Lodge will continue to distribute annual dues cards, this will allow those who have lost/misplaced their dues cards to attend Lodge in this Jurisdiction or in others where recognized. This will also allow visiting Brethren to attend our Lodges with a digital dues card. Many other Jurisdictions accept digital dues cards, and this puts the Grand Lodge of New Mexico in line with other Grand Lodges.

#### 5. Code 320. PROFICIENCY OF A MASTER MASON.

Add Paragraph (d).

(d). All Master Masons Entered, Passed and Raised after March 16<sup>th</sup>, 2024, will be required to pass suitable proficiency on the Master Mason Degree. Suitable proficiency must be completed.

by Committee, or in Open Lodge, then approved by the vote of the Brethren. The timeline for completion of the proficiency will be (1) one year after receiving his Master Mason Degree. If not completed within the allotted timeframe, the Brother will have to repetition the Lodge as in the preceding degrees. All Master Masons Entered, Passed and Raised prior to March 16<sup>th</sup>, 2024, will be exempt, and not required to pass suitable proficiency. Master Mason proficiencies from other recognized jurisdictions will be accepted. The Grand Master may waive this requirement with proper justification, such as relocation due to active military service etc.

Rationale: Once was the standard within the Grand Lodge of New Mexico to hold a Master Mason Certificate of Proficiency to hold the Office of Warden or Master of a Lodge, in addition to having experienced and accounted for the most sacred, solemn and spiritual vow any Mason can take. The MASTER MASONS OBLIGATION. This recommendation if passed would provide some level of proficiency requirement needed before he is elected to the Office of Warden or Master of a Lodge, this also provides completion of the Master Mason Degree before potentially petitioning membership within the Appendant Bodies of Freemasonry. This requirement would not affect the status of any current Entered Apprentice, Fellowcraft or Master Mason. The Grand Master would still retain the ability to waive this requirement with proper justification for special circumstances, Active Military, First Responders or through dispensation.

As long as we are willing to accept mediocracy, then mediocre is all we will ever be.

#### **Prior Precedence of Master Mason Proficiency Requirement:**

#### 1899 Constitution and Bylaws of the Grand Lodge of New Mexico - Article IX - Section 12.

Proficiency of Master Masons. All newly raised Master Masons shall stand examination in open Lodge on the first section of the Master Masons Degree within six months after their raising, which shall be recorded in the minutes.

#### 1922 - Constitution and Bylaws of the Grand Lodge of New Mexico - Section 12. Proficiency of Master Masons

Within six months after being raised, every Master Mason shall stand examination in open Lodge upon the first section of the Master Mason Degree as embodied in the Ritual of this Grand Jurisdiction, following which a vote shall be taken as to the proficiency of the brother being examined. Record of such examination and the action thereon shall be made in the minutes. If such examination shall be declared satisfactory, certificate to that effect shall be transmitted by the Secretary, under the seal of his Lodge, to the Grand Secretary, by whom a Master Masons diploma shall thereupon be issued at the expense of the Grand Lodge, to the brother thus passing such examination, embodying a certificate of his proficiency as a Master Mason.

#### 1930 - Constitution and Bylaws of the Grand Lodge of New Mexico - Article XI Petitions Section 12.

Same requirement as above.

#### 1965 - Constitution and Bylaws of the Grand Lodge of New Mexico - Miscellaneous Article XXIII - Section 12.

Proficiency of Master Masons. Within seventy days after being raised or for Master Masons affiliating, within seventy days after completion of transfer of his membership by the filing of demit, every Master Mason shall stand examination in open Lodge, or before committee appointed by the Worshipful Master, as provided in Article XV, Section 3, upon the first section of the Master Mason Degree as embodied in the Ritual of this Grand Jurisdiction, following which a vote shall be taken as to the proficiency of the Brother being examined. Record of such examination and the action taken thereon shall be made in the minutes.

#### 2007 - Constitution and Bylaws of the Grand Lodge of New Mexico - Code 191. Advancement.

(a) No Candidate shall receive more than one degree at the same communication. Before advancing from one Degree to another the Candidate must, at a regular or special communication, pass satisfactory proficiency examination on the proficiency lecture covering the preceding degree or pass a satisfactory examination covering the steps, signs, tokens and obligation of the preceding

degree, to be determined by the majority vote of the members present. This examination may be conducted by a committee appointed by the Master.

Brethren, in 1877, this Jurisdiction received its Charter issued by the Grand Lodge of Missouri, since then, and even before, The Grand Lodge of New Mexico has operated by the Landmarks, Rules and Regulations set forth by the Founders of our Fraternity. For almost 150 years we have operated in a manner that distinguishes us from all other Institutions. Sadly, within the past two decades we have relaxed those qualifications that separate us from others, those qualifications that obligate us to each other, and those qualifications that bind us to the Fraternity we cherish so much. So now, while there is a gaining demand for Freemasonry, let us return those essential qualifications and provide Freemasonry as it was meant to be for future generations.

#### 6. Grand Lodge of New Mexico Social Media Policy

Paragraph 1. (add the following) (If needed, please see the attached social media Policy in its entirety).

This policy governs the publication of and commentary on social media by officers, members and representatives of the Grand Lodge of New Mexico and its constituent Lodges and Organizations, (hereinafter refereed to collectively as "Grand Lodge of New Mexico) for the purpose of this policy, social media means any facility for online publication and commentary, including without limitation blogs, wikis, social networking sites such as Facebook, LinkedIn, Twitter, Reddit, YouTube, TikTok, Instagram and any other social media platform now, or in the future. This policy is in addition to and compliments any existing or future policies regarding the use of technology, computers, e-mail and the internet.

**Rationale:** To update the existing Social Media policy to account for new and future social media platforms used for posting content to the internet.

**Question:** Is the social media policy of the Grand Lodge of New Mexico just an addendum to our Constitution and Bylaws or is it an established Code.?

If it is not in our official Code, I would move for its official adoption, as it would have greater meaning and it is then enforceable.


