WB Herman was Raised to the Sublime Degree of Master Mason in Animas Lodge No. 15 in November of 1992 and has served in numerous offices in the Grand Lodge and the lodges in the Four Corners area of the state. Saturday, March 16, 2024

Saturday morning the Craft assembled at 8:00 am to pay last respects to the Brothers who have gone on before through that closely tiled door. MWB Bobby Arther conducted the memorial service. We bid farewell to 83 of our Brothers including our MWB David Lance Baker, PGM in 2009, who laid down his working tools just before the Annual Communication.

With these sad duties completed the Grand Lodge welcomed representatives from our Masonic Youth Groups. Representing the International Order of Rainbow for Girls was Miss Chloee DeWees the current Grand Worthy Advisor for the Grand Jurisdiction of New Mexico. Miss DeWees outlined her activities and service projects for her term and was very optimistic about the future of the Rainbow Girls.

DeMolay International was represented by Drake Bennett, the State Master Councilor, brought greetings from the several DeMolay groups within the state. They are planning a Kit Carson event in Santa Fe later in March, that will give Masons who did not go through the DeMolay programs when they were young a chance to become a DeMolay and have the experiences that they missed on their Masonic journey. The DeMolay organization in the State of New Mexico is very active and is working with DeMolay International to recruit more members.

Miss Victoria Blagrave the current Honored Queen of Bethel No. 2 of Job's Daughters International reported that there are still two Bethels in the State of New Mexico each with five active members and two to be initiated next week. They have active programs to fundraise for HIKE (Hearing Improvement Kids Endowment) and they are actively recruiting new members.

With the memorial and youth activities concluded MWGM Thomas Schenk called the Grand Lodge back to labor and called for the final credentials report from RWB James Overfelt. There was a total of 143 ballots.

It was moved and seconded that the IT Committee Report be approved. Motion carried.

MWB Jonathan R. Andrews was called to the podium to amend the Ritual Report that was an addendum to the program. There were 3 small changes to the report. 1) to change 274 to 283 Sections. 2) to add Wade Villanueva with 9 Sections. 3) Shem T. Peachey was recorded a Life Lecturer and he is a Deputy Lecturer. With those changes it was moved and seconded that Grand Lecturers Report be accepted – motion carried.

Because of the death of PGM David Lance Baker, the head of the Insurance Committee the report was not available and was withdrawn.

The Legal Advisory Committee report was withdrawn.

The Committee on Foreign Correspondence reviewed the request for recognition from six foreign jurisdictions:

A motion and second was made to recognize the six Grand Lodges as published in the program. Motion Carried. Motion was made and seconded to accept the report of the Committee on Foreign Correspondence. Motion Carried.

MWB Bobby Arther presented the report of the Appeals and Grievances Committee on the appeal in the matter of a trial in Dona Ana Daylight Lodge No. 78. The committee found sufficient evidence to send the case back to the lodge for retrial. There was a motion and a second to approve the report. Motion Carried.

LEGISLATION

The legislation held over from the 146th Annual Communication in Farmington, NM which was not acted on because it was not published in the program was <u>WITHDRAWN</u>

The resolution to amend Code 61. Annual Budget – to add section (F) one-dollar per capita contribution to the George Washington Masonic National Memorial shall be based on the total Master Masons borne on its roll as regular members on January 1st of each year. **PASSED**

Grand Master's Recommendations:

1. Chapter V – Standing Committees

Code 50. Appointment – That there be added (G) A committee on Legal Advisement composed of not less than five (%) Brethren all of whom are experienced in appraisal, beneficiaries, bequests, donations, gifts, environment, life insurance, litigation, real estate and

wills, to advise and facilitate when needed, to the Board of Directors on such matters as they pertain to the Grand Lodge. **PASSED**

2. Chapter 1 – Annual Communication

Code 1. Time and Place – That the code be modified to remove City of Albuquerque and replace it with State of New Mexico. **FAILED**

3. Code. 365. Requirement to visit.

That a sentence be added at the end of the code; Digital Dues Cards will be accepted from this Grand Jurisdiction and all other recognized Grand Jurisdictions. **PASSED**

4. Code 393. Dues Cards

That a line be added Digital Dues Cards will be accepted from this and all other recognized Jurisdictions. **FAILED**

5. Code 320. Proficiency of a Master Mason - That a paragraph be added (D)

(d). All Master Masons Entered, Passed and Raised after March 16th, 2024, will be required to pass suitable proficiency on the Master Mason Degree. Suitable proficiency must be completed by Committee, or in Open Lodge, then approved by the vote of the Brethren. The timeline for completion of the proficiency will be (1) one year after receiving his Master Mason Degree. If not completed within the allotted timeframe, the Brother will have to repetition the Lodge as in the preceding degrees. All Master Masons Entered, Passed and Raised prior to March 16th, 2024, will be exempt, and not required to pass suitable proficiency. Master Mason proficiencies from other recognized jurisdictions will be accepted. The Grand Master may waive this requirement with proper justification, such as relocation due to active military service etc. **FAIL**

A motion was made and seconded that the 148th Annual Communication is to be held on the third weekend in March 2025 in Hobbs, New Mexico. **Motion passed.**

The Grand Marshal was directed to proclaim and did proclaim that the officers both elected and appointed had been duly installed in their respective positions. The newly elected and appointed officers of the Grand Lodge of A.F.& A.M. of New Mexico were directed to assume their new positions. The hat was passed to collect funds for the family of fallen NMSP Officer Justin Hare. A total of \$2500.00 was donated and will be matched by the New Mexico Masonic Charities Foundation. The 147th Grand Lodge Annual Communication was closed in due form.
